

2011 Fall Governing Board Meeting Ohio Chapter of the American Fisheries Society Ashland Soil & Water Conservation District – Ashland, Ohio 10:30 am -12:30 pm, 12 December 2011

- 1) Call to Order eight members were present
- 2) Welcome by President Curt Wagner Deferred
- 3) Officer Reports
 - i) <u>President</u>: Curt Wagner NCD Update: AFS looking to revamp the certification program; seeking new chairs for a couple of committees; NCD wants to send officers to OCAFS annual business meeting at OFWMA and we are ok with attendance but not going to support travel or have time on the agenda; chapter role in advocacy is mixed amongst states; City of Cincinnati is pushing for the NCD to have Ohio host the national AFS meeting in 2016, but we are hesitant because of the following: time commitment, Cincinnati is not centrally located for OCAFS members, need buy-in from Division of Wildlife Administration, and the fact that we will be hosting the Midwest FWC in 2018.

 - iv) <u>Secretary/Treasurer</u>: John Navarro Chapter balance is \$4,739.26 which is below the \$6,000 target but we will track balance to make sue it does not drop below a critical point (\$3,000?). - i) <u>OCAFS By-law revision update</u>: Joe Conroy Got go-ahead form Parent Society to move forward with update. We will send out draft to the membership and then have a vote at the annual business meeting in February. We will then get approval from NCD and Parent Society.
- ii) Nominations for President-Elect: Curt Wagner It was mentioned that Tony Sindt from the Division of Wildlife would be willing to accept nomination as the President Elect.
