- 3) NCD Report Gratz (on behalf of Brian Nerbonne, NCD President)
 - NCD bylaw changes were approved
 - Lower membership since 2020 Covid year
 - AFS reestablishing Development Committee to focus on fundraising to address financial issues
 - AFS looking for potential sale or leasing of offices in Bethesda with proceeds going towards short- and long-term support of programs

- Multiple tech. committees wrapped up joint meeting in northern Wisconsin with speakers and fishing
- Reviving Salmonid Technical Committee (Contact: Mike Siepker)
- AFS sent out survey to members and non-members to see why people are and aren't members. 800 results for non-members with 30% not members of any society which are toughest group to market towards. Other societies are more important to some respondents. Considering partnering with to offer possible discount if holding multiple memberships (e.g., CASS Consortium of Aquatic Science Societies). Results to be shared with AFS Governing Board at Annual Meeting and shared with broader audience afterwards.

 - 44 Hutton Scholars in 2023 (534 applicants new record!)
 - o AFS needs more mentors and reviewers

 - Alford Stone Lab attempted to apply as host; host app deadline was ~3/1 but student deadline is Dec; mismatch means mentors need to apply quite a bit earlier to get student. Also, AFS wants mentors to recruit students so more of a burden

 - NCD Fisheries Excellence Award member who has made an outstanding contribution to the fisheries profession. This contribution may be a single activity or a collection of achievements over the individual's career.
 - Similar to Fisheries Management Section (FMS) Hall of Excellence Award – fish management related
 - NCD Meritorious Service Award recognize extraordinary service to the AFS by an NCD member. Nominations may be based on a single outstanding achievement or a variety of service activities, and may include the Chapter, Division, Section or Parent Society level. This is the Division's highest award and may not be given every year. (i.e., Distinguished Service Award)
 - AFS level award as well
 - NCD award may not be given every year
 - FMS Conservation Achievement Award recognizes any significant action, program, or initiative by a nonmember individual, non-governmental organization, or state (provincial), tribal, local, or federal agency that

contributes substantially to fishery conservation or fishery science.

- Fish Habitat Section Rising Star Award Student and early-professional nominees must be a graduate student (MS or PhD) or an early-career professional who completed their terminal degree within 10 years of nomination. This award recognizes the achievements and contributions of emerging leaders to the field of aquatic research, education, conservation, and management. Reflects ongoing and exceptional growth to include leadership and mentorship.

Dave Schuller introduced the Castalia Trout Club: Founded 1879. Origin springs feeding Cold Creek were important. 52-54F water, 5.3 miles of stream on CTC property. Club has responsibility to maintain quality of stream. Algae blooms have been an issue, tough to control (measures have been temporary). Braig tipped them onto Oxbow group that have helped to develop plan for mgt of Cold Creek. Algalcides haven't worked, draining muck temporary. Now have Master Plan with new trees, increasing flow rate, utilizing wetlands to improve water quality for all water users. Precious resource that club members feel responsible for maintaining. Now have foundation to keep Cold Creek water quality good. ODNR have also helped – proposal to improve Castalia Pond to improve water quality (issues from goose droppings). Have submitted to H2Ohio this year, cautiously optimistic. Unique fishery with a small club (60 members from CLE, CBUS, national NY, CA, MI). Looking for input and advice if OCAFS members have it. Have water quality monitoring and hatchery.
